Woodson Honors 2016-17 Scholarship Recipient



RIF at the Honors Breakfast, Expanding

At the Honors Breakfast in May 2016, the foundation's Madison Reading Is Fundamental (RIF) Book Distribution Program gave out 200 new, multicultural, high interest books to honor students and other students at the James C. Wright Middle School in South Madison.. The book distribution program has been approved by RIF for the last 22 consecutive years. With this special approval status, the program is able to purchase new books up to a 75% discount from approved vendors. RIF is the oldest non-profit literacy organization in the United States and distributes more than 5 million books annually to more than 17,000 sites across the country. According

to RIF, 47% of fourth graders from low-income families read below the basic level. Additionally, more than 80% of children from economically disadvantaged communities lose reading skills over the summer because they lack access to books, learning resources, and such enrichment opportunities as trips to the library, bookstore, or museum. It is the goal of the Madison RIF Book Distribution Program to provide reading material in the homes of underserved children and to foster reading as a life-long activity. In 2016-17, the program will add one elementary school and the Boys Club Mentoring Program to its current sites.

Boys Club Going Strong at Jefferson

The Woodson Boys Club Mentoring Program for African American Middle School Boys is continuing its Scope of Partnership Agreement with Madison Metropolitan School District to operate a boys club at Jefferson Middle School in West Madison. The purpose of the mentoring program is to help close the academic achievement gap between the boys and their counterparts and to establish lasting relationships with the boys. The program also focuses on equipping the boys with leadership skills, providing various cultural enrichment activities that the boys would otherwise go without, engaging them in community service activities, and assisting them in their progression as young men. A cultural enrichment field trip to a major museum in Chicago is planned for spring 2017. Under a group mentoring model, the boys attend monthly sessions with mentors of the foundation. Sessions are modeled around the principles of

Learning, Accountability, Maturity, and Preparedness. In an effort to further build enduring relationships, the boys engage in some one-on-one time with mentors. Some of the topics for this year's monthly sessions include Goal Setting, Study Skills, Black History Presentation/Activity, Perception of the Black Boy, Image/Grooming and Appearance. Time Management, Financial Literacy, and Interacting with

Law Enforcement Officers. Other components of the mentoring program include a Parent/Boys Orientation and End-of-Year Recognition/Awards dinner. The Reading Is Fundamental Book Distribution Program Director is working with the Cultural Enrichment Program Director to infuse books into the mentoring program to encourage the importance of reading as a life-



long activity. Measures of program effectiveness include grade improvement, fewer behavioral incidences, and improved attendance. In order to remain participating in the mentoring program, boys must adhere to a code of conduct and show continuous improvement in accordance with the overall objectives of the program. The foundation has targeted 25 boys over the 2016-17 academic year.
